Ordering Procedure All orders must be received in writing using the Renegade Wheels fax order form. You are also welcome to use your own purchase orders if you have a system set up to do so, as long as all applicable information is included. Please add any specific notes to the order form so that your order may be processed accordingly. Renegade Wheels is not responsible for any incorrectly ordered parts and any returns or exchanges may be subject to a 15% restocking fee. The customer is responsible for all shipping charges. If you would like an estimate only, please indicate this in the notes area and one will be faxed or emailed to you. Delivery time is approximately four weeks unless specified otherwise.

Discount Levels and Payment Terms Your discount level will be assigned to you upon review of your dealer application and determined by the information provided to us. A catalogue and price list will be sent to you upon approval of your dealer status. We will also send one via email or fax. Payment must be received before an order will ship from our location. You may send a company check once your order is confirmed, or you may use a credit card of your choice. A 3% transaction fee will be applied to all orders, however, it may be waived if paying with a company check, bank check or money order. Credit cards will be billed upon shipping, with the exception of special order products, which require a 50% non-refundable deposit. Please contact us if you are interested in setting up an open account.

Limited Warranty Chrome plating on Renegade Wheels' Products is warranted for two years from the original purchase date. The warranty is non-transferable and limited to the original retail purchaser. The warranty registration form must be completed and returned, along with a copy of the sales receipt or invoice, to Renegade Wheels for the warranty to be honored. Products must be returned for inspection and determination of repair, replacement or credit at Renegade Wheels' discretion. Please call our office for a return authorization. Wheels will not be accepted with tires, rotors, sprockets or pulleys mounted unless Renegade Wheels mounted or assembled these items. The customer is responsible for shipping charges associated with returning defective product to Renegade Wheels for warranty inspection. No credit will be issued for labor or any cost incurred beyond the original purchase price of the part(s).

Warranty Exclusions The condition and appearance of chrome plating is largely dependent on user care and maintenance. Products should be maintained properly by cleaning with mild soap and water, and waxing with a high quality carnauba wax. Small flaws and/or marks do not constitute a flawed product and are not covered by warranty. Corrosion defects due to salt spray in beach or snow areas, corrosive chemicals, improper care or cleaning are not covered by warranty. The following are not covered by warranty:

- *Any items which have been subject to misuse, negligence, racing, improper installation, collision or damage from wheel weights.
- *Damage to the surface finish of the wheel or accessory as a result of stone chips or similar road hazard.
- *Damage to the surface finish of the wheel or accessory as a result of the use of polish, abrasives or rubbing compound or the use of acid based cleaners.
- *Any wheel or accessory installed on a vehicle other than a the vehicle in which it was designed for.
- *Any wheel or accessory that has been repaired or altered by a party other than Renegade Wheels.
- *Corrosion or defects not resulting from manufacturing defects in workmanship or material.
- *Damage due to off-road or unlawful operation.

Non-Warranty Items Rotors, pulleys, sprockets and bearings are considered wear items and are covered for the first 90 days after purchase. Replacement items can be purchased at a discounted rate.

Non-Warranty Returns All returns or exchanges are limited to 90 days from the invoice date. Any items being returned for exchange or credit must be authorized in advance and may be subject to a 15% restocking fee. Special order items are not returnable. Please call Renegade Wheels' office for a return authorization.

Minimum Advertised Price Policy We believe that it is important that our dealers provide skilled, professional assistance in demonstrating, explaining, selecting and purchasing Renegade Wheels products. We also recognize that our dealers must earn sufficient profits to provide those services. However, we have determined that the advertising of our products at prices below our MSRP undermines Renegade Wheels' industry reputation, image and marketing strategy. Therefore, we reserve the right to unilaterally terminate dealer status with any dealer that advertises Renegade Wheels' products at a price less than our MSRP. We will update all dealers in the event that the minimum advertised price changes. Dealers may also contact us if further clarification on advertised pricing is necessary.
